Mendez and Magistrate Judge Dale A. Drozd for all further 17 proceedings, and any dates currently set in these reassigned cases 18 only are hereby VACATED. Henceforth, the caption on documents 19 filed in the reassigned cases shall be shown as 2:12-CV-00886 JAM-20 DAD, 2:12-CV-00888 JAM-DAD, 2:12-CV-01260 JAM-DAD, 2:12-CV-01262 21 JAM-DAD, 2:12-CV-01459 JAM-DAD, 2:12-CV-01513 JAM-DAD, and 2:12-CV-01514 JAM-DAD. 22

IT IS FURTHER ORDERED that the Clerk of the Court make appropriate adjustments in the assignment of civil cases to compensate for this reassignment.
