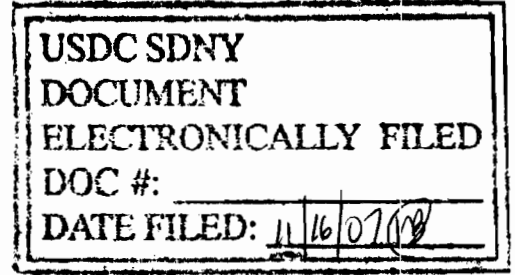

ORDER ALLOWING SERVICE BY E-MAIL AND SERVICE

ORDERED that service shall be deemed complete
upon the filing of a declaration with the Clerk of the
Court affirming that the e-mail has been sent in conformity
with this order; and it is further

ORDERED, pursuant to Rule 26(d) of the Federal
Rules of Civil Procedure, that plaintiffs may serve a
subpoena on PayPal, Inc. to identify and locate defendants
Nadir Knyane d/b/a Gabbanax d/b/a Nadcorp and John Does

Nos. 1-5 in this action;
