20 NOTICE is hereby given that Plaintiff Righthaven LLC (“Righthaven”), hereby appeals
21 the Judgment in a Civil Case entered in this action on the 15th day of August, 2011 (the
22 “Judgment”, Doc. # 44) to the United States Court of Appeals for the Ninth Circuit. The
23 Judgment entered in favor of Defendant Wayne Hohen (“Defendant”) was based on, and
24 Righthaven’s appeal in this action includes, the Court’s August 15, 2011 Order (Doc. # 43), the
25 Judgment (Doc. # 44), the associated briefing by the parties in connection with Defendant’s
26 Motion for Attorney’s Fees and Costs (Doc. ## 32, 38, and 40), the associated Order Granting
27 Defendant’s Motion to Dismiss for Lack of Subject Matter Jurisdiction and Order Granting
28 Defendant’s Motion for Summary Judgment (Doc. # 28), and the related Clerk’s Judgment (Doc.

1 # 30), all of which will properly be designated separately as part of the record on appeal by
2 Righthaven.

3 On July 19, 2011, Righthaven filed a separate Notice of Appeal to the United States
4 Court of Appeals for the Ninth Circuit challenging the Court's Order Granting Defendant's
5 Motion to Dismiss for Lack of Subject Matter Jurisdiction and Order Granting Defendant's
6 Motion for Summary Judgment (Doc. # 28), and the related Clerk's Judgment (Doc. # 30). (Doc.
7 # 33.) The United States Court of Appeals for the Ninth Circuit designated Righthaven's initial
8 appeal as *Righthaven LLC v. Hoehn*, Case No. 11-16751.
